

# CHAPTER 6

## THE EFFECTS ON NORTH AMERICA

We've already covered in the last two chapters the changes to the topography of North America resulting from the catastrophic earthquakes in late October and early November of 2008. Let's look at what other problems will occur and what else will change.

### PRECURSERS TO THE QUAKES

**Gaia**—Besides my warning, what other warnings will people see and hear about the coming quakes—even the ones just before the quakes happen? *“Yes there will be a number of warnings. The birds will begin a migration of sorts to safer places, thanks to efforts of their divas. Various insects and rodents will start to leave their homes signaling eminent danger. Dogs will bark incessantly. Horses and cattle will become extremely restless. I will give them many types of warnings so that they will know to leave or not. Some people will ignore the warnings and others will act. There will be other people this information will be given to, but you are the most important cog in the machinery of notification, as you will be much more believed by many people than the others.”*

Will the animals and other creatures—birds and so on—begin these warning weeks or days in advance, or right before? *“They will start to become agitated and leave a few days before each quake.”*

Please confirm or not the following precursors to the earthquakes:  
*Roosters flying to tops of trees—“ Yes, they will do that, especially in the Mississippi Valley.”*

*Flies and mosquitoes disappear from an area where they normally are infested—  
“Again yes in the case of the Mississippi Valley.”*

*Cats run away—“Most certainly in both regions of the country.”*

*Surface fish or fresh water fish will jump out of the water in droves? “Yes, that will certainly happen more in the Mississippi Valley, but also in places on the Pacific Coast.”*

*The air becomes unusually hot and dry? “Yes, there will be that phenomenon more on the west coast.”*

Gaia responded with a “no” to my questions regarding deep-sea fish beaching themselves, water in lakes and rivers turning muddy, and water tables changing.

## INTENSITY OF THE QUAKE

Will these earthquakes be “Megathrust” quakes or another type? *“Good question Tom. They will be Megathrust earthquakes, as the earth will be shoved up causing these massive movements.”*

How deep below the surface will be the New Madrid earthquake? And the same question for the Pacific Coast earthquakes? *“Yes, a good question Tom. These earthquakes, as you may have deduced, will be much more shallow than the earthquake that occurred near Peru (August 15, 2007, magnitude 8.0), which was about 25 miles or 39 kilometers below the surface. The New Madrid earthquake will happen only 6 to 7 miles below the surface—yes you are receiving that figure correctly. So it will be very strong, but shallow, so that the plate will move. The Pacific Coast earthquakes will also be shallow—along the same line of 6 to 7 miles below the surface too.”*

So I want to get these figures correct. It will be less than 10 miles (16 kilometers) below the surface? *“Yes that is correct Tom. More on the order of 6.7 miles (9 kilometers).”*

Gaia—How far will the North American plate move to the east and how far will it move to the west when the New Madrid Fault line ruptures? *Let’s see if you can receive this. The plate will move to the east only a few feet—less than 10 (3 meters), but the movement of the plate to the west will obviously be significant—fully 30 feet (9 meters) or more. That may not seem like a lot but it will be enough to move the North American plate off of Mexico with the resulting collapse of the lower part of California and the Baja Peninsula into the ocean.”*

At a different time I received slightly different numbers. So I want to get this correct as I sometimes have problems with figures, as you know Gaia. It will move less than 10 feet to the east? *“Yes, that is correct--8.2 to 8.7 as I think your figures are fairly accurate today.”*

And to the west? *“Certainly almost 30 feet or 9 meters, so it will be significantly larger move than the move to the east, which you expected anyway, I know. But you are correct here you see.”*

So I’m not exaggerating the numbers for the movement to the west coast? *“Perhaps just a little, but not much Tom. This will be close enough for the scientists that read your book to make their own calculations to determine what will result from that much movement to the west.”*

**Gaia—Will people be able to hear the sound of the P Waves either in the Mississippi Valley or on the Pacific Coast? “Yes they will be able to hear the P waves in both places as these earthquakes—these series of earthquakes will certainly have a loud boom to begin with and then the severe earth movements that I have previously described to you.”**

**What will be the length of the slip motion when the North American plate slips over or under the Pacific Coast plate and which is it? “Yes you are correct in thinking that the slip motion will be over the Pacific Plate. The slip motion may be a little difficult for you to receive, but certainly in this case that 30-foot figure I gave you will be correct, or close to correct, perhaps slightly less.”**

**Will the slip length be over 1,000 miles? “Most certainly. As I have mentioned before, the pressure will be all along the border between the Pacific plate and the North American plate.”**

**How long will the earthquakes last in minutes? “Certainly several minutes in time. It will seem to many people that stay there instead of leaving that it will never stop, but the energy buildup is tremendous and when loosened will vibrate like a bell for several minutes time.”**

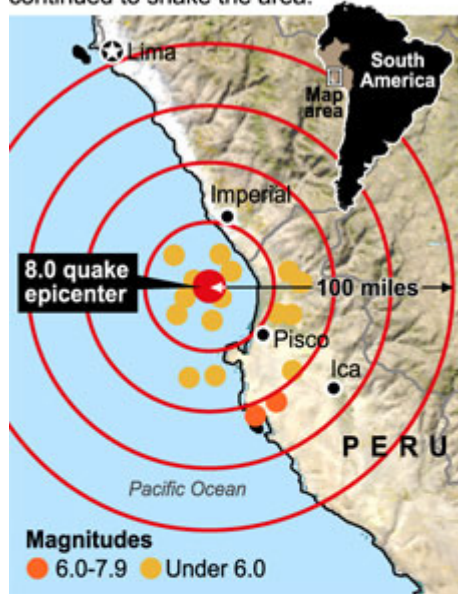
**What strength will the aftershocks be? “There will be massive aftershocks, Tom. They will be in the 8.0 range, slowly subsiding down into the 7.0 range, 6.0 and 5.0 ranges. The earth will move back and forth in those areas for some time, making it impossible for those people in those areas to live. They will have to move elsewhere in order to survive. Their homes will be quickly unlivable, as if they are not destroyed in the first series of earthquakes, they will be weakened so that the subsequent series of earthquakes will take them down.”**

**How long will these aftershocks last before really subsiding? “It will be over six months before they really subside to rumbles.”**

**The “Abridged Modified Intensity Scale” measures intensity of earthquakes from I to XII. I assume that both earthquakes will be on the XII measurement or would they be considered somehow stronger? “No they will be certainly both be at the top end of this scale. But you are correct that if they had a higher degree of intensity, these two earthquake events as you call them would be even higher on the scale. Again, the people who created this scale have no concept of how great the intensity will be. They could only imagine the worse case scenario, so to speak, and put that at the top of their scale.”**

**A chart on USA Today illustrated the number and magnitude of earthquakes in the 12 hours that began with the first earthquake in Peru. Here is that chart:**

An 8.0 magnitude earthquake was felt nearly 100 miles from its epicenter just off the coast of Peru. And a series of aftershocks have continued to shake the area.

Which led me to my next question. When the earthquake in Peru occurred, there were 17 earthquakes recorded in a twelve-hour period. How many will there be in the first 12 hours in the Mississippi Valley and then on the Pacific Coast? *“Ah, an interesting question Tom, but one that at this time even I am not sure how many. Certainly each area will experience similar numbers. They will be even higher in magnitude than those recorded in the first 12 hours in Peru. Part of this is because the earthquakes will take place at a higher level than the ones in Peru, so they will cause more damage.”*

Will there be any well-known dams that will collapse or break either in the Mississippi Valley or West Coast area? *“No Tom, the dams that service these areas such as the Hoover dam will have cracks but will not break. It will be touch and go for a while. They are far enough away that they will remain standing. Most of them are built quite solidly. As I said before, the dams that will break are those earthen dams that are poorly constructed or old and have deteriorated, such as the levee systems.”*

Will liquefaction be mostly in California or other states as well? *“This is a good question Tom. It will not be limited to California, but to any place that has a lot of soil that will liquefy with severe shaking. It will turn to mud if you will and will not be able to support structures. This will be for all the areas—both the cities and states of the Mississippi Valley and those on the Pacific Coast. Liquefaction will go hand in hand with the movement of the earth.”*

## REFUGEES

Gaia—with the flood of refugees starting in 2008 after the quakes, how will the cities handle such a mammoth problem? *“It will extremely difficult as you can imagine. There will be a great wave of humanity clogging the roads and gas will run out stranding these people along the roadside. Only those with gas supplies that they have stored will reach far enough away so that they will find gas stations with supplies to continue on their journey. There will have to be airlifts of gasoline and needed food and supplies. This will be more in California, yes than the Mississippi Valley, as the population is more concentrated on the western coast than it is in the Midwest. There will be supply breakdowns, but not of the severity of the west coast.”*

Will there be a few that will heed the warnings to have sufficient supplies or a larger number? *“Only one percent or less will heed the warnings. We are speaking of the ones who choose to stay and experience these earthquakes. As you can see, you have your work cut out for you, as you sometimes like to say.”*

So all the normal earthquake survival suggestions that are published and promoted by local governments will be of some benefit? *“Yes they are good suggestions up to a point. But keep in mind that this will be the largest earthquakes in modern times so that it will make the earthquakes in other parts of the world seem small or even tiny in comparison.”*

Gaia—How long will it take to find housing for all the refugees of the two earthquakes? *“Some perhaps never will Tom, as they will be too destitute and will become wards of the state, so there will be a large increase in homelessness in this country. But for the majority of the people, it will take at least two to three years for new housing to be built, from apartments to trailer mobile home housing and even old hotels will be pressed into service to meet the needs of these people. Many will have to be reschooled in order to change from a job that can no longer be done to jobs that can be done anywhere. Yes even resorts will be used to house these people in the short run. From cabins to beach condos, people will be placed in whatever accommodations are available in that area they travel to.”*

Gaia—It’s my understanding from reading news accounts of the last time in the 90’s an earthquake was predicted for the New Madrid Fault line that many thrill-seeking people will be attracted to these danger zones like moths to a flame. How many of these thrill-seekers will perish in this manner? *“Quite a large number Tom. It will*

*be over 500,000 people will perish who are attracted to experience these earthquakes. Do keep in mind that their life contracts for this life are up and their souls have chosen to depart in this manner.”*

*How many other thrill-seekers will have to fight for their lives to be rescued? “An equal number, Tom. Again this was chosen for them to experience in their life plan before birth. It’s called a “survival experience.” It’s the same in a way for those that survive floods, tornadoes, and hurricanes.”*

*Will there be wide spread looting after the earthquake, or will everyone be more attuned to escaping? “No, you are correct in your assumption that there will be much looting for awhile, although many of these looters will find themselves in very precarious circumstances as the earthquakes continue and they are caught in houses that suddenly collapse. You understand that they are loved equally, and this will also be a lesson to these younger souls that greed has its consequences.”*

*How many suicides will be attributed to the two earthquakes? “Certainly a large number. Many will have lost loved ones and cannot go on. So certainly in excess of 100,000 to 200,000 people will take their own lives.”*

*Clean water will not be available in what percentage of the urban areas? “Certainly easily 80% to 90% of the area affected by the earthquakes will not have clean potable water for weeks, as the water mains will be broken and there will actually be no one to repair them for quite some time. It will be too dangerous for people to work in the ground that is still moving. Those that try will be caught in cave-ins.”*

*Will there be wide spread disease in the earthquake zones? “Yes, as you guessed Tom, there will be diseases of several types. Let’s see if you can receive these. Certainly there will be cholera that will break out. There will be inflammatory diseases from the dust and chemicals in the air. People will have severe asthma attacks. Some will die from these attacks. There will be burning sensations in people’s throats and nostrils from the airborne pollutants. These will result in cancers in some people that do not flee. Yes some people’s lungs will take on a black appearance as you are visualizing right now. Of course, there will be starvation, which will lower their immune system to a wide range of diseases. People’s eyes will burn from the airborne pollutants. And yes, there will be heart attacks from the stress caused by these events. Any medical condition a person has will be heightened by prolonged stays in these earthquake zones, as you call them.”*

**A little more information on Cholera--it’s a disease caused by ingesting contaminated water and food. It causes severe gastrointestinal symptoms such as diarrhea, abdominal cramps, nausea, vomiting and dehydration. There will be no clean water and little food for months after the earthquakes, not to mention the lack of electricity, gas, and of course running water. And don’t forget all the dead bodies lying around. You will endanger not only your life, but also the lives of your family by returning too soon. STAY AWAY!**

How long will it be before people can return to earthquake-damaged areas? *“The ground will shake for months afterwards. It will be quite dangerous for anyone to try, although certainly many will try. More lives will be lost from that impatience. It will be best to allow these areas to take care of themselves so that there is little disease to worry about. Therefore certainly one year to 18 months would be the best timing.”*

There will be a huge amount of pollution and refuse on both the Mississippi River and the ocean off the Pacific Coast. How long will that take to subside—and I will combine two questions, as even without the pollution there will be a mass of dirt left on the surface, I’m sure. *“Yes you are correct on both counts Tom. There will be great pollution of the waters, especially those off the Pacific Coast, as the Mississippi will fairly quickly—over the period of a year or so--return to what people will call it’s normal look, although with a much greater volume rushing down its banks towards the Gulf of Mexico. The pollution off the west coast will take several years to dissipate, so life along this coast will be impossible for a period of time. Yes the dirt will float on the surface until it slowly sinks into the ocean too. And to answer what you are thinking, I have ways to handle pollution that will neutralize it sooner than you think, although your scientists will study how to speed up the process themselves.”*

Will there still be chunks of land falling into the ocean for several months too? *“Yes, certainly there will be. The action of the waves and storms will continue to loosen the coastline so that a lot more land will disappear into the ocean for at least a year or two.”*

Will there be many survivors that will refuse to leave the damaged areas even though their homes might have been destroyed? *“Yes, unfortunately. They will bring harm to themselves through disease and the continued action of the earth, along with injury from the destroyed houses. They will be moved forcibly to safe areas, although certainly there will be some that will refuse and will hide in the wreckage.”*

It appears there be many people with no shelter and possibly no food or water? *“Yes, you are correct. People will have to fend for themselves in those quake areas before help arrives. There will be lawlessness and people will arm themselves to protect themselves, their families, and their property. But your country has the resiliency to overcome these tremendous challenges.”*

Won’t assistance be slow in coming due to the enormity of the situation? *“Of course it will. Many national guard units will be mobilized, army medical units, thousands of volunteers, but they all have to be fed and housed and they all have to get to these areas that will still be very unstable for weeks and possibly months. It will take some time for things to settle down.”*

## COMMUNICATION

**Gaia—What about radio and TV stations in these earthquake areas such as California? Will any be operating? “No, of course they will not be, as if the earthquakes and tsunamis do not take them down, liquefaction of the soil will cause the collapse of many towers.”**

**So how can the Red Cross or government contact these people? The only thought I had was for helicopters with loudspeakers go up and down the highways telling people where the supply dumps and any help was. “This that is certainly a good solution, Tom. They might also consider having some mobile transmitters that can be airlifted in that would at least have a range of 10 or 20 miles. Certainly those people with TV satellite dishes, if they were to have backup generators in areas not as affected by the earthquakes would be able to receive information and pass it on to their neighbors, along with those that have satellite radios.”**

**I guess that the communication problem will also extend to mobile phones, as they require transmitters too? “Yes, their mobile phones will be virtually of no use until they are outside the earthquake zones Tom. Some landlines will still be in use, but not very many.”**

**We have not touched on the effects of the earthquakes on the phone systems and service. Can you go into detail? “Yes, the earthquakes first will cause the collapse of phone system relay stations and main stations too. Along with that will be the collapse of transmission towers for not only cell phones but for satellite dish feeds. It will be extremely difficult for anyone to contact someone either in one of these earthquake zones, if they are still alive, or for the people in those zones to call their families and friends or to call for help. This will take months and even years to repair.”**

**How will the earthquakes affect the US Air Controller system in 2008? “As you can imagine Tom, there will be great disruptions and many airplanes will be grounded at first until they see what systems are still in operation. Certainly as you read the system in Memphis, Tennessee will no longer exist so that the air controllers as far away as Chicago and Dallas/Ft Worth will be pressed into service to try and handle what in actuality will be a greatly decreased load, as there will be no flights from the west coast nor from the Mississippi Valley airports, if ever again in some cases, including Kansas City. Denver will also be placed in the same situation of assisting flights from Las Vegas, along with Albuquerque and so on, but at first as you can imagine there will be chaos.”**

## **HOSPITALS & TRAUMA**

**How will the hospitals cope with the earthquakes? “As you have guessed, they will be overrun and will be aided by other countries that will send complete hospitals that are mobile in nature and they will send nurses and doctors to supplement those already working in your hospitals. There will also not be enough space for all of the people with injuries and large warehouses, schools and so on will be pressed into service to**



*handle the disaster. Medical supplies will also be brought in from other countries as your medical supplies will quickly vanish or be used up in treating the injuries.”*

**Gaia**—will there be sports teams from other parts of the country that will be lost to the earthquakes? *“Yes of course there will be as you guessed. This will bring great grief to their families located back in the cities they came from, but they will be there by contract. Those that are not you will see some injuries or other problems that will prevent them from being there. College ranks will be slimmed even more. Keep in mind Tom, that after these events nothing will remain the same. There will be great changes in everyone’s lives, as you must adjust to the new circumstances.”*

The traumatic effect of these earthquakes will last a very long time, will they not? *“Yes, quite so; part of your population will be frightened of any small rumble or vibration in a building and will run out the door as you have seen years ago in the earthquake you experienced in Los Angeles. Naturally it occurred while you were there so that you would have a little understanding of what these people will go through. Yes there will be even TV programs produced to assist people psychologically.”*

I suppose many people will from that time on have a fear of living on a coastline? *“Yes. It will be a deep-seated fear. But do keep in mind that I want them to move to the interior. I need the coastlines to be less densely populated.”*

## **MILITARY**

Will troops be pulled from Iraq in order to assist in rescue and to keep order and help with clean up? *“Certainly there will only be a small force left after these events as the state officials will demand that there troops be recalled to assist in the recovery in all types of ways—construction, guards, rescues, body recoveries, demolition of unsafe structures in those area that can be reinhabited, and so on. Please understand that this will take every resource your country has and it will still be not enough as no one could predict such a catastrophic event or events as you prefer. Your book will be ignored in many quarters as being, as you have said, science fiction. That’s as it should be, as people will then have to question their own belief systems. This will be a result that you had not thought yet about, that people will have to question why they’re here on earth and what purpose, and why they rejected your warnings as being impossible to happen. There will be a shift in vibrations after these events Tom to a higher level. This is necessary for the planet as well so that the level is raised high enough for the next phase of the shift from one dimension to the next.”*

## **PROPERTY OWNERS**

Will much of the property located elsewhere and owned by Pacific Coast and Mississippi quake victims will be put up for foreclosure if relatives can't be found? *"Yes that is correct, Tom. Yes there will be an enormous number of foreclosures."*

Will there be a forgiveness of mortgages in the future for people's houses? *"The mortgages will be partially forgiven, but not all."*

How will this affect the mortgage companies that are national in nature and hold the mortgages on not only businesses buildings and homes located in these areas, but also mortgages elsewhere owned by these quake victims? *"There will be mortgage companies that will go out of business as you can imagine, although the Federal government will step in to assist here, as this will be a national calamity for the nations (I'm including Canada and Mexico here too). There will be many homes and businesses put up for auction. We have spoken before about the number of refugees flooding your area and increasing the size of your city by several hundred thousand people seemingly overnight. Billions of dollars will be lost by these mortgage companies, so they will need federal assistance and even that may come too late for a number of them."*

Will there be new companies formed to handle all the problems that the quake creates? *"Yes there will be salvage companies that are formed to salvage as much as possible from the new edge of the continent. It will be dangerous work, as the earth will still be moving and adjusting at that time. But many homes will be abandoned and all the fixtures and home devices removed and sent to areas like yours for the refugees to start over."*

## **SPACE PROGRAM**

Won't our space program be completely put on hold after this event, as there will be little money to fund the program? *"Yes for a while, but it will come back as private companies take over the development of space travel."*

I don't see how we will be able to continue working on the Mars mission and other great things—even other moon missions, as the United states will be so drained of money in refugee and reconstruction efforts that it will take generations to pay all of this off it would seem, as people will have to start over with absolutely nothing. *"Yes many will say that is true Tom, and it is true that everyone will have to pay for this. But they will want to keep people working and contributing to society and taxes, so there will be money found to continue these research and development efforts, with the other countries picking up the majority of the tab—the cost. Life has to go on even though there will be a great grief that lasts in this country for many years until those that were part of the event pass over. These are all learning experiences for everyone Tom, not just those whose homes are destroyed. Many souls will pay off karma by being able to help their fellow humans and in doing that you will dramatically raise your vibrations and those of this planet as well. Keep in mind what 911 did for*

*bringing everyone together and how much good came out of a tragic event. This will be looked upon perhaps not for years as a positive event but one that resulted in many positive results for your nation and the world in general.”*

## **AFFECT ON OTHER CITIES**

**After the major earthquakes, what will happen to property values in places like Dallas, Houston, Chicago, and the other Midwest cities with a huge influx of refugees? Will houses and apartment values soar, stay the same, or be controlled by the government? “Yes they will soar at first, as the people with money will pay anything for a roof over their heads. But for the poorer people, the government will step in with massive aid as was done during the Katrina hurricane crisis and will pay for housing—as much as there will be of it-- and there will be virtually large tent cities with thousands of people in them as they wait for adequate housing. People will be asked to take in families and singles to assist. Even that will not be enough. So to answer your question, the rates will soar, and then will be capped by the government. There also will be government subsidies or payments to people who take in refugees.”**

**Even in Dallas and other cities not affected by the earthquakes, won't there be major shortages of food? “Absolutely. It will take some time for food to be sent from other warehouses and even that will not be enough. There will be disaster relief from other countries with massive food shipments and other supplies. This event will bring many people together to work towards a common goal and there will be much compassion along with the heartache.”**

**People on the East Coast of the U.S. are making plans in case they ever have a tsunami. From previous questions, am I still understanding that they will not suffer a tsunami after the quakes in 2008? “That is basically correct although certainly the seas will be agitated, there will be some larger wave activity than normal, and there will be a great deal of beach erosion.”**

**So is that how you will move people away from the East coast, or will you also use some sort of tidal wave on Tsunami created by the west coast quake? “There will be, as I said before, some wave action that will travel around the world, and which will cause damage, but the real damage will be from rising seas. There will first be flooding caused by the great tidal wave or tsunami created by the fall of the land into the sea on the Pacific Coast. Of course it will affect other lands first, but there will be a rolling effect with huge tides on the east coast. This is such a major event that no one has seen or witnessed in thousands of years, so there are no records of it occurring before.”**

## **WEATHER CHANGES**

Will the East Coast experience more hurricanes after 2008? *“Yes, they will experience more. The strong storm systems that are going to travel across the lower portion of the United States will combine at times with weather systems from the Gulf and the Atlantic to spawn hurricanes. So to answer your question, yes, there will be more hurricanes that will strike the East Coast. Count on it. Again I want the people to move away from the coasts. They must, as the seas will rise over 18 feet in the future.”*

Will Atlanta see a great increase in rain and weather? *“Of course, as you notice they are situated right along the path of the weather systems that will travel along the lower part of North America and their rainfall will increase just at Dallas and all the other cities in this rain belt we’ll call it, with rainfall amounts at least in the 60 inch level per year.”*

How else will you cause the people on the East Coast to move inland? *“Oh, they will be affected Tom. There will be movement even on the East Coast but also water –the ocean will be used to push them back. The earthquakes will cause huge sections of the arctic to break away and melt, which will raise the level of the seas faster than is predicted at this time. Weather patterns, as I have mentioned before will dramatically change and the arctic and Antarctica will both begin to melt more rapidly, bringing that rise in sea level I mentioned to you before of two feet or so within three to five years. It will cause major flooding along the East coast as storms will flow inland more. More wave action will severely damage many of the structures that line the beaches causing them to collapse or be so damaged as to not be inhabitable in a short time.”*

OK, so the figure here I understand in two feet? *“Yes, it may not seem to be a lot, but that is quite significant.”*

Right after the quakes will the weather be highly unsettled? *“Yes the weather will be quite unsettled. You will have a lot of dust in the atmosphere for water to collect on and there will be muddy rains, as you might call them, caused by the interaction of the dust and water vapors. It definitely will rain more frequently until the dust comes down mostly as rain, although certainly some will come down as dust storms. Yes, you see the vision I’m sending of great dust thrown into the air just from the ground shaking and not just from the Pacific Coast collapsing. That’s what I mean by a lot of dust being thrown into the air.”*

Please explain in more detail the weather patterns that will be in effect in or on the United States after 2008. *“The new west coast will see more rain and the rain will not be stopped by mountains but will more easily spread across the lower half of the United States. It will slowly turn Arizona and the desert southwest into a much more verdant zone with almost a tropical rain forest effect in some places. As I have said before, Las Vegas and that area will be awash in water, with flooding, and they will have to work to adapt to those changed conditions. It will take a few years before it becomes verdant, and capable of growing crops again, but that will be the end result, as people see that*

*these rains that will come are doing so on a steady consistent basis and not just a short term reaction to the earthquakes.”*

**How often will these weather systems migrate across?** *“Actually, every few days. The southern part of North America will become very verdant, as you will be able to grow many foods and plants that you could not before. It will be a green belt all across the USA, yes and including Arizona and Nevada and New Mexico and those dry western regions of Texas. These regions will receive more than three times the rain than is normal now and perhaps four to five times in some years.”*

**Following up on this I asked what would our rainfall average in North Texas, when presently the average is 34 inches per year.** *“You will receive fully double that Tom—around 60 inches a year.”*

**Will there be an increase in tornadoes in the United States?** *“Yes, the storms that you are seeing right now will be the type that quickly move across the southern part of the United States and will spawn more tornadoes, as there will be more storms.”*

**What percentage increase in tornadoes will there be for the plains area?** *“Certainly 40% to 50% more. You will have very active weather systems that will constantly flow across the southern part of the United States and will meet with warm air with the result of more violent storms.”*

**Will there be a new “tornado alley?”** *“Yes, as you guessed it will move farther to the south and will be along the line of the major storms coming from west to east.”*

**I assume you mean in my region of the country (Texas)?** *“Yes, certainly. There will be more and larger in size and more numerous in clusters as you have seen in visions before. But also they will start to be reported in areas that have never had tornadoes before.”*

**And I assume that hurricanes will be more frequent?** *“Yes, certainly again. I allowed a quiet year this time, but next year will see the start of much more activity.”*

**OK. Phoenix and Albuquerque receive 8 to 8.5 inch respectively of rainfall per year. What will be the amount of rain they receive?** *“Not quite as much but still enough to make their deserts bloom as they not have in several thousand years. They will receive over 30 to 40 inches of rain per year.”*

**In contrast, since above them is Salt Lake City, what will be the average rainfall there?** *“Still up around the same—35 to 40 inches per year.”*

**And Las Vegas? Will that city receive around the same amounts as Phoenix and Salt Lake City?** *“Yes exactly. These western areas will soon have moist winds that have not been dried out by the mountains, so they will receive these larger amounts of*

*rainfall each year. Farming communities will quickly be established, as farmers see the change in weather patterns.”*

Why will Texas and the other Gulf states average more rain –you said 60 inches per year—than will Arizona, Nevada and New Mexico, as the storm systems will come from the Pacific? *“Interesting question Tom. Yes they will have moisture that will cause rains, but this moisture will couple with the Gulf moisture to give the rain systems more water to work with, so they are more heavily laden with water and therefore will rain more heavily on Texas and then the Gulf Coast areas. That’s why I said this area will become more sub-tropical.”*

I think Sedona, Arizona is one of the most beautiful places in America, so I had to ask about its future, as I had read that it might someday go underwater again. *“This town will certainly have much heavier amounts of rainfall, Tom. If you think it is beautiful now, come visit it in five to ten years.”*

After the earthquakes in 2008, will the jet stream no longer bend upwards as it reaches North America? *“It will bend upwards still but lower down, which will produce the rain I need to sweep across the southern United States and then across the ocean. That’s why you will continually have unsettled weather patterns.”*

*“Your central-southern part of the continent will have changes with violent storms much more prevalent than before, with the heating combining with the moisture. Structures will need to be built or reinforced to withstand the violent winds that will be created quite often. Of course, there will be more water, but the population will have to adapt to these more harsh conditions at times. The temperatures will be more moderate, but still extreme for parts of the year. Winters will be harsher with more rains and snow and ice. Don’t forget that the widened Mississippi River will be a weather maker in its own right when the sun evaporates the water and carries it aloft to form thunderstorms. It will be a much more interesting and exciting time.”*

Am I to understand that temperatures will not rise too much in the southern United States? *“Yes you are for the most part correct about that. There will be more humidity in the air with more storms sweeping across the country. This will allow more goods of a tropical nature to be grown, as the heat and humidity will combine to allow this. Air conditioners are a must, but then the majority of the southern part of the United States already has these in place, yes?”*

So how fast will the temperature rise and humidity go up? *“Quite fast . You will notice significant changes in the next four years certainly, even the next two.”*

Will the Texas region continue to have that high-pressure system sitting on top of North Texas in the summer? *“Yes, to a certain extent it will. But it will tend to move more frequently back and forth from the east to the west and vice versa, so your temperatures will fluctuate much more than they do now.”*

So will it be warmer or hotter than average now, or will it be cooler, or about the same. *“The temperatures on average will be slightly warmer, but not significantly so. Yes you are receiving me correctly. Your weather will be more unsettled as there will be more rain, storms and yes hurricanes to contend with.”*

What about the storm systems that have gone across the U.S. and Canada in the past—will they continue to do so? *“Yes but in more moderation. There will not be such a deluge in the Pacific Northwest during the winter as has been the case in previous years. They will not receive as much rain, but sufficient to be fertile.”*

How will weather systems go south after the earthquakes, as most of our weather comes from the Northwest? Even Los Angeles is a very dry area as is San Diego. *“Yes but the weather systems will change and will dip farther to the south. They will be drawn there, almost magically it will seem to you, but your weather forecasters and meteorologists will study and gain knowledge of how this works and will increase their understanding of world weather systems and how the land plays a part in this scenario.”*

*“The northern states will see more moderate temperatures than in the past. They will have warmer summers and milder winters than in the past. There will not be so many McFarland signatures with the jet stream pulling down such arctic temperatures as before. It will be stormier as I have said in the south and those storms will make their way across the Atlantic to Africa. You are going to see on your televisions some amazing scenes of rain in the deserts of Africa—the Sahara starting to bloom again after thousands of years. It will become verdant again with much rain, and many crops will be grown there in the coming years. Also the same for the Middle East as these storms will hold together across both continents. War will fade from the scene.”*

How will the climate change in the middle section of the country from say Northern California across Nevada, Utah, Colorado, and into the plain states? *“They will be a little more moderate and somewhat warmer than before. There will not be so many blizzards as before. The weather will be more gentle and moderate there. That, as I said, will not be the case for the lower half or third of your country. These storms will intensify when they come into the plains states as they collide with warmer air from the Gulf of Mexico to produce some amazing storm cells. They have to be strong in order to hold together across the Atlantic to Africa. Although Africa will still have some storms form off the coasts because of the climate change, the systems from North America will provide the fuel to create storms that will go across the desert there.”*

As I have skied for over 40 years, naturally I asked how the snow cover in the mountains of Canada and the United States would be affected. *“Yes they too will be affected. The snow will be less in many places, but there will be summer storms they have not had before to compensate for the reduced snow levels. Yes there will still be skiing as the operators of resorts will compensate for the reduced snow levels with snowmaking machines that will be even better than the ones of today. I know you were worried about this, but there will be even later snow in the springtime from storms and*

*will lengthen the ski seasons for these resort operators. As I have said, conditions will moderate, so that the northern areas of the world will allow more people to live there than could before, so that as people must migrate away from the oceans, they will find homes in these northern climates acceptable and fresh for them to work with. You will see many cities and towns spring up and densify the land in these northern climes.”*

**Will temperatures moderate in Canada?** *“Quite so. There will be a great reduction in the Arctic ice cap with the breakup of the ice and their weather will be much more moderate—much closer to what perhaps the middle of the United States is now. Because of this change, that region of North America will attract many more settlers to populate the smaller towns and villages and they will grow much larger than they are today.”*

**What about the weather in Mexico?** *“Mexico will have more rain, as part of their coast will disappear, and as I mentioned previously the storm cells will be dipping much farther south than before. The more arid parts of Mexico will have much more rain in their forecast also.”*

**You told me that the humidity would rise within 2 years. Will that be because of the earthquakes or for what reason?** *“Yes, the humidity will increase and it will be due to a number of factors. First is the bulging of the earth, which will create weather patterns that have not been seen before, or not in the frequency you have seen before. Then of course the earthquakes will add to this by creating new weather patterns that will come down lower on your latitude but will not just end at your eastern shores but will continue across the Atlantic to Northern Africa and the deserts that are there. All will start to receive much more rain and it will revitalize the deserts and in a short time make them verdant again and habitable for those people that have been clustered on the shores of the African coast and other coasts as well.”*

**How will the storms come out of California when the mountains appear farther away than 50 miles?** *“The mountains that are blocking these storms will either not be there any longer, or will drastically change their shape and appearance to allow these storms or rain systems to flow across the southern part of North America, not just the United States, but also Mexico. Again, you will be sub-tropical in nature, with the heavier amounts of rain I have spoken to you before materializing.”*

**So the mountains in Southern California are the culprits so to speak in blocking these weather systems?** *“Yes, exactly. The mountains in Northern California, if you study the weather there, do not block the weather systems, or if they do, it is to a lesser effect.”*

**I assume an area such as Utah, that has a number of arid areas, will see a lot more rain, but from low pressure systems coming or bringing the rain from the south instead of so much from the northwest?** *“Yes, exactly. The low pressure systems will feed rain on up toward the Salt Lake City area, so that the more arid parts of the state*



*will bloom and crops will be able to be grown there not just next to the rivers and streams but over a much wider area.”*

**Am I to understand that only a rise in the ocean level will affect Florida? “That’s mostly correct Tom. Florida will remain the same for a period of time before the waters rise and many parts of Florida that are low lying will be flooded.”**

**Will Hurricanes increase in number after 2008? “Yes they will. There will be warm waters and cooler air.”**

**But you said the storms would go from the United States across the Atlantic to Africa. In the past they have come from Africa across to the Caribbean, Mexico and the United States. “Yes that is true. There will be still a circular motion but you asked if there would be more hurricanes and I said yes.”**

## **THE ELECTION & THE ECONOMY**

**Will one or both of the earthquakes delay the U.S. Presidential election? “No, but they will make some effort for those who wish to partake in the election to do so. In reality, all resources will be stretched beyond the breaking point in trying to cope with rescue efforts so that the election will really be down the list of priorities. Only in those areas not so greatly damaged will the election process be attended to.”**

**How long will it take the United States to recover economically and physically? “Easily 25 years. Such a massive event will cause an enormous change not only in the coastline of California, but in weather patterns, and in the concentration of humans in where they live in the USA. This is an event that will shape your lives for the rest of the century in many ways. It will take generations. But that is where you also come in and will be one of the people to assist in understanding the event and recovering from it.”**

**After the 2008 quakes, how will the U.S. operate with so much national grief? “Good question Tom. There will be a paralysis of sorts, as people will not believe that this has actually happened. There will be much fear and many will not be able to sleep at night as they relive images not only from the television news, but also from the actual experiences of millions of people.”**

**Will the earthquakes and tsunamis that take place in 2008 raise our vibrations worldwide? “Yes, a good question Tom. They will greatly raise your spiritual vibrations, as there will be an outpouring of heartfelt sympathy for your people and compassion. It will bring you closer together with many of the peoples of the world, not only your previous friends but even old enemies will take pity on your plight and will respond accordingly. This outpouring of compassion will be several times more than that of 911 and you will be awash in feelings of heartfelt compassion. It is truly a**

*needed event for what is to come. And as I said it was planned long, long ago—eons of time.”*

**On one hand you have said previously that the Iraq war will be paid for over the next few generations, but won't that pale in comparison to the loss of infrastructure and the cost of rebuilding it after the 2008 quakes? “Yes, the tax man will cometh. Everyone will have to pay their share to rebuild your nation. These problems will put you in the back seat, so to speak, in regards to other world problems. You will give up your leadership in these areas, which will be good for you as a nation in the long run.”**

**I was given more information when I asked how could we continue to be the peacekeeping force of the world after 2008, if all our resources are spent on recovery from the quakes? “Your peacekeeping will be greatly cutback, but there will be some forces used to help keep the peace, as naturally your enemies will want to take advantage of the crises posed by the earthquakes. This is where the European Union will step in and start to take over from you the peacekeeping, as they will understand that you will not have the resources available to do the task. Peace will be coming to the Middle East around that time period anyway, as forecast by Kryon several times in the past. It will not happen overnight, but the beginning of peace will be at hand. There will be many militants still that will want war, but will be prevented from doing so. That does not mean that the Al Queda factions and so on will not be active, as they will try and take advantage of your plight, but the European Union will take charge admirably and keep the militants at bay in their caves and hiding places. An interesting question. As you can see, there are reasons behind events that tie into needed changes. There can be a 1001 reasons for just one event to happen, even the wildfires that are happening in California have multiple reasons for their occurrence, past even the most obvious ones you can think of. It also has to do with shifting the population out of those areas, as the other events will be soon happening.”**

**Since you wish the population to move away from the coasts, there will still have to be ports for ships and for the trade of goods? “Yes there will still be ports, some of which I will create that will handle shipping of goods.”**

**Besides the obvious loss of population and migration of humans away from the California coast or I should say that whole area, what other benefits to you will that change bring about? “As we have discussed before, the weather will change and formerly desert areas will become verdant again. The coastline also has been depleted of resources and this will give it breathing room again to recover. People will visit but not nearly as many will want to live there, as the fear of further earthquakes will remain long after I am finished with the movement of the land. There will also be interesting discoveries of long ago settlements that people will see and learn about other eras such as the Lemurian period.”**

**As this huge amount of information accumulated over months, I asked why am I being given all this information and seemingly no one else is. “You are given this information because you will disseminate this information at the right time, which you**

*will be informed of. You are not able to see the larger big picture, but your talents will be utilized, as you have agreed on a soul level to do.”*

*So what is the big picture? “A conundrum. I was referring to your part in a much larger scope of events that will happen. You are a communicator of information that will assist people in making wise decisions as to whether to move or stay, what to have on hand to eat and drink, how to live without electricity for weeks or months, sanitation, and basically how to get along without governmental assistance that will be overwhelmed with such a large event.*

*“Look what happened in the smaller situation that was Katrina. It is still not back to normal after two years. Many people are without even a roof over their heads and the houses that flood still sit there wrecked and not taken down and hauled away. How do you think it will be when many thousands more are affected both by the New Madrid fault quake and then right on its heels the California collapse of one third of the state into the ocean? There will be power plants that were serving hundreds of thousands of people that will suddenly vanish. Power plants that will take their place will take years to build. It will be the same with water, sewage, and so on. All of the infrastructure that is needed for people to live will take years to rebuild, if ever.*

*“With these taken away, they will be forced to migrate to cities that have not been affected or little effected. It will place a huge burden on all those cities, especially ones that are perceived as larger cities like yours that would seemingly be able to handle a large influx of people, but as you saw from Katrina, those services are only partially able to cope.*

*My daughter and my friends say don’t buy into the doom and gloom prophecies that keep coming up about cataclysmic events. How say you? “Though these predictions do seem like doom and gloom, they are necessary adjustments I must make in order to have your country and others appear the same as it already does in the fourth and fifth dimensions. And I must do this for many other reasons as well. The climate has to change, as you are becoming a more temperate world. You have already seen how much warmer it has been for you this summer (2006) and that your whole year is over two degrees warmer than the warmest year on record. Though this will back off some in 2007 with more rain headed your way, these changes are necessary and the people involved have contracts to experience these events. I’m sorry that it must be done, but on a soul level you all understand this and are in agreement with me. This is not something I arbitrarily decided one day. This has been the plan for much longer than you can imagine. Keep in mind that other regions of the world have had catastrophic events, and will have more. So do not think that you are immune to these things happening.”*

## **FOOD SUPPLIES**

**How will fishermen and farmers be affected?** *“A good question Tom. There will be a mixed bag here of what will happen. As I mentioned to you farmers in northern climates will be able to grow foods or crops that only the lower southern regions have grown in the past. And the southern farmers it will be the same thing as they will be able to grow crops that were grown more towards the equator. Fishermen on the other hand will find a great disruption in their trade, as the fish population migrates or moves out of one area to another, confused about the rising water and water temperatures, so the fisherman’s work will be very difficult until they too learn of the migrations and where to go to catch the many different types of fish they were catching before, and will be even able to catch fish that would have been too difficult to fish for before.”*

**How will both earthquakes affect the food supply for the USA in 2008?** *“It will be greatly affected Tom. Obviously the food supply from California will be reduced, along with wines. There will be some shortages at times such as fruit juices—not only orange but others as well. Other crops such as corn or those grown on the big farms in the middle of California will be curtailed for a time. Gasoline shortages will be acute, as the pipeline from Alaska will be destroyed. And life will seemingly come to a standstill for California and the Mississippi valley as they dig themselves out of the rubble in survival mode. Keep in mind the time of year this will occur. It will be fall – late fall-going into winter, so temperatures will be cold in certain parts of the country, making living conditions harsh for some of the people affected. There will not be enough heating oil to go around. America’s dependence on these oil supplies will be brought to the front and things will start to change there. Yes rice harvests will be greatly affected in the Mississippi Valley as farms are inundated with water.*

*“Also keep in mind that some of your largest ports are on the west coast. They will be there no more, so goods from Asia will have an extremely difficult passage around through the Panama Canal to Houston. New Orleans will not be there to help. There will be gigantic problems to solve and will throw your country out of being a leader and into the class of being a survivor for many years to come. But as I said before, that is part of Explorer Race training and education to learn how climate changes and earth movements can affect a population. You are the great problem solvers of the universe and this will be but another challenge that you will handle.”*

**Any other shortages you did not cover?** *“Yes there will be many shortages, but you have some of the main ones. Even paints that are oil based and any product made in the USA dependent upon oil will be affected.”*

**Will oil and gas wells be broken in mass by the movement of the plates and crust east and west?** *“No, they will not be broken in mass, but certainly a number of them will be broken and will have to be repaired or redrilled as the case may be. It really does depend upon the depth of the well and its location as to whether they will remain in a working state.”*

Will any of the fundamentalist religions in the United States start to moderate after the earthquakes or will they stay the same? *“Another good question for today. They will stay the same for a while, and as you guessed they will take these events as the coming of the end of the world. But when it does not happen, they will have to “take stock” as you were and see that these are natural events. This will cause many people to question these leaders –evangelists and such-- that try and use control over their flocks for their own benefit. Their congregations will start to diminish or slip away into more moderate beliefs, along with a large number of people that will actually start to meditate themselves with your and other’s assistance and discover their true being is within and not without.”*

Will the changes in the West Coast and Mississippi Valley help balance you Gaia? *“A good question Tom. Yes it will help balance me and will allow me to bring water to arid parts of me that have not seen significant water in eons. It will give my earth surface a more temperate environment. And to answer you question, no, there will be no areas of the earth that will continue to be extremely arid. There will be more rain certainly and even more snow in parts of the world that will melt in the spring to fill lakes and give people sufficient water to live on my surface.”*

What percentage of the people who heed my warnings will move away from the quake zones a month or more in advance? *“As you have guessed Tom it will be a fairly small percentage – perhaps only 1% to 2% at a maximum. The majority of the people that heed your warnings live on the Pacific Coast and will see the New Madrid quake happen. At that time, and with your quick visits to the west coast cities, there will be a large movement of people that will flee in time to not be there when the land begins to collapse with the earthquake activity there in November of 2008. It will be very difficult for you to make inroads in the Mississippi Valley, although don’t be discouraged. You will reach those who will heed your advice and at least be away from the area at that time even on vacations.”*

## FEAR

Gaia – Will many of the people that die in the earthquakes have earlier lives on earth or will it be another planet similar to this one? *“This was a good question to start the day. They will have lives earlier in time on this planet and their souls will also have lives on other planets that will directly or indirectly assist them in coping with the stress of lives here on earth.”*

Won’t they have an ingrained fear of earthquakes? *“Of course, it will stay with them for eons and they will not want to live anywhere there is earthquake danger. If you were to meet them you would think that the earlier life was somewhere else and not the United States or North America where they died in these earthquakes.”*

Another thought—why so many on the west coast in comparison to the number that will die in the Mississippi Valley? Was it just because they could squeeze in so to speak with the larger population? *“Yes, of course. But there are other factors at*

*work there also. The lives of those in the Mississippi Valley are on average more spiritual than many on the west coast. Even if their lives revolve around a church, they are attempting to raise their spirituality in the best way they know. Of course, many “God-Fearing” people will be lost in the Mississippi Valley too. But their vibrations are somewhat higher than the west coast.”*
